A request was received from an adjoining Parish Council to assist them in gaining co-operation from the organisers of the Deloitte Ride Across Britain cycle event to ensure that adequate stewarding is in place to prevent the disruption caused by last year's event being repeated in 2015. It was agreed that contact with the event organisers would be sought once the new Parish Council is elected.
