- 112/16 Highways and Footpaths
 - a. Report from Highways & PROW Working Group.
 - JJ reported on a meeting with BBLP regarding safety concerns at Crossways. BBLP agreed that the white lines are in need of repainting and this will be added to the maintenance works schedule. As there had been no reported accidents at the junction in recent years no further signage or traffic calming measures would be installed. It would be possible for the Parish Council to fund such measures but these would require traffic surveys before being sanctioned by BBLP.
 - b. Lengthsman and P3 Schemes, Expression of Interest. *Resolved: to continue in both schemes and apply for the maximum level of funding available.*

c. Bus Waiting Area.

Attempts to contact the member of the public who had made the request had been unsuccessful and therefore it was considered not to be possible to determine whether the need still exists.

Resolved: not to proceed with this matter at the current time but to review in the future should the need be considered sufficient
