## NOTICE OF VACANCY

### Yatton Parish

**NOTICE IS HEREBY GIVEN** that a casual vacancy is deemed to have occurred in the office of Councillor for the **Yatton Parish** following the **resignation** of **Bernard Vincent Morris**.

Rule 5 of the Local Elections (Parishes and Communities) (England and Wales) Rules 2006, provides that on a casual vacancy occurring in the office of **Parish** councillor, an election to fill the vacancy shall be held if within fourteen days\* after the date of this notice (i.e. no later than **Thursday, 12th August 2021**) has been given in accordance with section 87(2) of the Local Government Act 1972, notice in writing of a request for such an election has been given to the proper officer of the council of the district within which the **Parish** is situate by **TEN** electors for the **Parish**.

If a request for an election is not received by the above deadline then **How Caple, Sollershope & Yatton Group Parish Council** will co-opt a person to fill the vacancy as soon as practicable in accordance with the Local Elections (Parishes and Communities) Rules 1986.

If there is an election, it will take place not later than **Friday, 15th October 2021**.
