# Mobile COVID test teams out and about



Offering tests on site in some locations. Helping you to carry out regular testing whenever and wherever you need it.

The testing programme for Covid-19 is playing a vital role in helping to keep us all safe by identifying those who have the virus, but no symptoms, so that they can self-isolate and avoid

passing the virus to others. Around one in three people who are infected with Covid-19 have no symptoms. Rapid testing using <u>lateral flow test devices</u> (LFT) is a fast and simple way to test people who are not showing symptoms, and helps us to stop spreading Covid-19 without realising it.

# Vaccination appointments still available in Herefordshire.

Vaccination is the best defence against Covid-19.

Clinics are still available in Herefordshire for anyone over the age of 16. If you haven't had yours yet, <u>you can book here</u>. Alternatively, you can just walk in but only for Pfizer vaccinations.

#### **Booster Vaccinations**

You can <u>book your COVID-19 booster vaccine dose online</u> if you are a frontline health or social care worker.

Once you have been contacted by the NHS, you can also use this service if you either:

- aged 50 and over
- aged 16 and over with a health condition that puts you at high risk from COVID-19

You may be contacted and asked to book online or at a local NHS service such as a GP surgery.

#### Grants

Six million County Covid recovery plan

Using a six million pound grant from the Government Herefordshire Council has put together a number of projects to support a recovery of the economy and community. Business grants will be available and promotion of the county to support tourism and hospitality sectors. Advice for return to work, re-skilling at a one stop shop and new youth employment Hub to support young people not in education, employment or training.

Encouraging people to return to towns with free weekend bus travel, refurbished shop fronts, discounts and investment in public rights of way and seating areas as well as various measures to improve physical activity and support people's wellbeing including basic mobile and iPad lessons and free adult learning swimming lessons.

#### Community and personal resilience grant:

There are grants of up to £10,000 available for projects that will increase capacity in voluntary and community groups, to promote greater personal and community resilience, following the impacts of Covid-19. #### Get active cultural activities grant:

Grants of up to £10,000 are available for projects that support the development of cultural activities, to improve mental health and wellbeing and get people engaged back into society,

## Community climate and nature grant:

Grants of up to £15,000 are available for non-profit organisations and parish councils to support new projects, which deliver carbon reduction and / or ecological enhancement in local communities. The funding is limited and match funding may also be required. The application process closes on 15 December 2021.

# Boost for new and expanding businesses

Businesses looking to take a first-step into retail or move into commercial premises in Herefordshire for the first time can now get grant funding support.

Start-up businesses wishing to try retail with either a pop-up type arrangement or taking on a retail premises can now apply for a grant of £500 - £2,500 towards rent, marketing and small equipment purchases.

Existing businesses wishing to take on retail or commercial premises for the first time can now apply for a grant of  $\pounds 2,500 - \pounds 10,000$  towards rent, alterations/making good premises and purchasing equipment.

The 'revive and thrive' business support grants are being funded from the Government's Covid-19 outbreak management funds grant as part of Herefordshire Council's Covid-19 recovery plan, supporting economic recovery and improving wellbeing in Herefordshire.

# Mental Health

Since March 2020 Talk Community has received 3,500 requests for support, and has coordinated over 300 volunteers in ensuring those isolating received food, medication and access to financial aid where required. 19 Talk Community hubs have launched over the first four months of 2021 which provide information, advice and signposting to residents within communities and a network of volunteers to connect residents into their communities.

## Queen's platinum jubilee 2022

I recently informed in my report of the forthcoming Parishes are starting to address their



plans for celebrating the Queen's platinum jubilee next year and the Green Canopy campaign. I would welcome working with Parish councils and landowners on tree planting as part of the Queens Canopy campaign

I am given to understand from those more knowledgeable than me on species to plant. Apparently, the best way is to stand where you are going to plant the tree(s) and have a good look round 360 degrees- identify the trees that are growing well in that area- then chose those to plant.

Do NOT plant Ash or Elm (unless it is a resistant variety).

Do plant some shrubs in amongst the trees- again look round and see what is growing locally. All trees will want protection, weeding and care into the future. Remember that trees grow so planting near houses, walls and roads will not be sustainable so please give that particular thought.

## Herefordshire Armed Forces Covenant

The Vice Chairman of the Armed Forces Covenant was recently interviewed on BBC H&W about this (last Monday 27 Sep). He essentially said that a significant number of the veteran community would be happy to help, in co-ordination with wider Council policy. Veterans who had served in Afghanistan were only too well aware of the bravery of those who had helped to UK forces, and the risks that were taken. I also made the point that if the situation was reversed it would not take much imagination to guess how vulnerable any transplanted families from the UK would be feeling, and much help they would hope for and need.

#### Force for Change: Veteran to veteran volunteering

Herefordshire Veteran Support Centre, which provides support and a friendly listening ear for anyone in the armed forces community, is looking for help from local organisations.

The centre is aiming to expand its Force for Change project, but needs help to identify veterans in the county, who would potentially benefit from its low level 'buddy buddy' system and also those veterans who would like to volunteer.

It became evident during the first coronavirus lockdown, that veterans talking to veterans, immediately allowed common ground and trust to be built, enabling problems to be freely discussed and resolved.

Local residents warned not to lose their voice in decisions that affect them.

The annual canvass ensures that Herefordshire Council can keep the electoral register up to date, identifying any residents who are not registered to vote so that they can be encouraged to do so.

# Colette Maund, Electoral Registration Officer at Herefordshire Council said: "It's

important that residents look out for messages from Herefordshire Council's Electoral Services, so we can make sure we have the right details on the electoral register for every address in Herefordshire. We will be sending out our annual canvass communications over the next few months for you to respond to. Please simply follow the instructions sent to you."

People who have moved recently are particularly encouraged to look out for the voter registration messages from Herefordshire Council and check the details.

Research by the Electoral Commission, published in 2019, indicates that recent home movers are far less likely to be registered than those who have lived at the same address for a long time. Across Great Britain, 92% of people who have been at their property for more than sixteen years will be registered, compared to 36% of people who have lived at an address for less than one year.

# Apply for a Postal Vote - Local by-elections

After the recent elections in Herefordshire I would take this opportunity to advise that you may apply for a postal vote, at any time, for the local election in **May 2023**. So if you can't get to your polling station for whatever reason, or you do not want to vote in person at a polling station, you can apply for a postal vote; but you must be registered under Individual Electoral Registration first. You may register for a postal vote for upcoming election please review:

The deadline for the receipt of new postal vote applications or to change or cancel an existing postal applications for all elections is 11 working days prior to polling day. Postal vote ballot papers are normally sent out about a week before the election.

**Upton Bishop:** The proposal to install traffic lights at Old Gore crossroads continues to be discussed with the local land owner but there is a start date of October 18<sup>th</sup> 2021 and the works will continue until completion until January 17<sup>th</sup> 2022 when the work is expected to be completed and the junction fully signalised.

# **Report fly tippers**

If you spot someone fly-tipping

- Make a note of any vehicle used, including model, colour and registration number. If it is safe to do so without being seen, take a photograph or video of the activity
- Note the fly tippers' clothes, and distinguishing features. If you can hear the fly tippers, take note of anything which was said along with the speakers' accents
- Make a note of what they dumped, the location, weather conditions and how far away you were at the time;
- You may report fly tipping on an app on the website and available for download.

If you are on a low income, you may also be able to get help to pay your bill through Council Tax Reduction. We will need to assess your financial and other circumstances to see what help you qualify for.
