Dear Residents

I continue to provide regular updates to ensure residents are informed of key developments and information across the ward and the wider county, involving the council. As I have said before I reach out across the council for information to provide my ward report for you to receive what I consider to be interesting information.

I would like to say thanks again for your cooperation and understanding with the various highway closures we have had while some of our roads have been resurfacing. This has been the largest investment in the highways for many years, and we await to see the governments funding proposals to see if we can allow ourselves more capital investment. The resurfacing funding is a council decision to borrow money using our capital fund and replay over 20-30 years which puts a cost on the revenue account. Sadly, we are getting limited highways funding from central government.

Herefordshire Council members had the opportunity to meet the recently appointed Chief Constable for West Mercia Richard Cooper and the Police and Crime Commissioner John Campion. Councillors discussed a wide range of issues including Children safeguarding, drug issues, modern slavery, traffic matters including speeding. West Mercia Police like other parts of the public sector are having to make significant savings and one of these is to reduce the working hours of our Community Support officers in the evenings. This means we are unlikely to have our PCSOs attend Parish Councils meetings and many of us voiced our concerns about the matter.

The chairperson of the council is working on a scrutiny review of Broadband and network coverage in the county by the council's connected community committee. Access to quality broadband and network mobile signal is vital to our communities and I want to better understand the existing barriers and future developments, so we are not disadvantaged in our rural areas.

I am sorry that this is another long report but there has been a lot going on at the council. Notwithstanding, as ever if I can be of any help, please don't hesitate to contact.

Council Information



As I informed last month of the retiring of the chief Executive next Marc. This month I inform of the appointment of our new Director of Economy and Environment. Following the departure of our previous director Ross Cook, tthe Council has appointed John Hobbs from 2006 the Director of Economy and Infrastructure at Worcestershire County Council as our Director for Economy and Environment from the end of October. John is a qualified quantity surveyor and solicitor, he has held senior roles in the private sector with organisations including Tarmac, Bombardier, and Alstom Transport, and has led major infrastructure and regeneration programmes and brings a strong track record of delivery and partnership working. He arrives in Herefordshire to lead on the first

phase of the Hereford Bypass, completing the development of Ross Enterprise Park, overseeing our public realm contracts to keep the county running smoothly. In addition, he will oversee the development and implementation of the new Local Plan, Champion environmental sustainability and the council's response to improving the health of the county's rivers, everyday operations of the council, such as waste, parking, planning and enforcement.

Finance and budget.

As you know from information shared, next year is going to be difficult and challenging financially with the Government's fairer funding scheme for councils. At this stage, our estimate is a budget gap of £27m, which is subject to confirmation through the settlement figure from the Government in late December.

We'll be lobbying the government directly, including writing to the Chancellor, Rachel Reeves. Both our MPs will raise the issue in Parliament and with ministers directly highlighting the financial challenges we now face because of a major real-terms reduction in government funding. Directors are working closely with their teams to develop proposals to deliver further efficiency savings through our continued transformation, options for reductions in services and the impact these cuts will have, and how we can earn new and additional income. This work will go on into November and December as we finalise the proposals.

Last week saw the start of a series of briefings about The Fair Funding Review. The Chief Executive will meet with all the political groups to answer their questions and concerns and raise awareness and understanding about our financial challenges. We will continue to brief both staff and members on the review as our position becomes clearer.

A renewed commitment to collaboration has been presented to councils across the county, with parishes invited to adopt the newly published Charter for Herefordshire's Councils 2025. This

new agreement, which has already been adopted by Herefordshire Council and other parish councils, is designed to enhance partnership working, improve service delivery and empower communities across the county.

New PROW Maintenance Delivery Plan

We are pleased to announce a new Maintenance Delivery Plan to support all the brilliant work being done by PFOs and City, Town and Parish Councils through the PROW Grant scheme and volunteering time. Officers will now be able to call on the services of local, Herefordshire Contractors to assist us in delivering across the network from a maintenance perspective – from installation of fingerposts to largescale vegetation cutbacks requiring machinery. The very first batch of works have been bundled up into a package and requests for quotes will be sent out over the coming days.

Previously, Herefordshire's Public Rights of Way team were able to use an arrangement with Hoople to get works done by operatives across the network however since this service level agreement was cancelled in around August 2024, officers have struggled to react to all service requests in a timely fashion. This new Delivery Plan will help to speed up our responsiveness on the ground and therefore is very much welcomed by the team.

Other Team News

As set out in our September report, Callum Bush left Herefordshire Council a couple of months ago and we advised that we were in the process of recruiting into a new Principal Public Rights of Way Officer position. We are pleased to announce that from Monday 3rd November 2025, Shona Butter will join as the new Principal Public Rights of Way Officer. Please give her a little time to settle in! She will attend future LAF meetings and present our report. Shona joins us following a long and successful career in Public Rights of Way with Shropshire Council and will therefore bring much needed knowledge and experience to assist us on our improvement journey.

In the previous report it was mentioned that we did not have an Enforcement Officer in the team at that time. The Enforcement Officer has now returned to work, and we are finalising how our Enforcement team will be provided with increased capacity in the future. More details will be shared regarding this as soon as we are able to.

We are pleased to say the team continues to receive a record number of compliments from users, volunteers, internal colleagues and elected members. Service areas will typically receive several complaints during each month however the team is keen to hear when we are getting things right too.

Highways Investment

We know that the condition of our 2,000-mile highway network is important for our residents and businesses in Herefordshire. Over the course of 2024/25 and 2025/26 the Council has almost matched pound for pound the capital maintenance funding that it receives from central government to maintain our carriageways, footways, bridges, street lighting and drainage systems.

Total expenditure on our highway network through our partner contractors and local suppliers has risen from £26.760 million pounds in 2023/24 to £50.870 million pounds for 2025/26. Of this total, £25.2 million pounds will be invested in the resurfacing of those parts of our network that require the greatest attention and undertaking preventative treatments such as surface dressing to help keep other roads across the county in a condition fit for use over the years to come.

As of today, our investment is well underway with 30 miles of resurfacing, 58 miles of surface dressing works, and associated drainage improvement works already providing smoother journeys for our road users. Just under £20 million pounds has now been spent or is in the process of being delivered on the ground, all of which can be seen at https://www.herefordshire.gov.uk/roads-1/herefordshire-road-investment#map, which provides a transparent map of our investment over the past 18 months.

We will not stop in our efforts to maintain Herefordshire's roads, and our team of dedicated highway engineers are currently working with our partner contractors to deliver the rest of our investment by the end of March 2026, as well as looking ahead to finalising our plans for April 2026 onwards, once we know our funding allocation from central government.

Pride in Place Strategy

The phrase "pride in place" likely refers to the **UK's new £5 billion** Pride in Place Programme, which will fund 339 deprived communities across the UK over 10 years to drive local change and tackle regional inequality. The specific locations receiving funding are being announced, with some neighbourhoods in Birmingham and other areas identified for the initial phase of the program.

The government gave a briefing last week on their Pride in Place Strategy – Southwest Hereford has been chosen as one of the 250 most deprived wards in the county as an area to benefit from Pride in Place funding of £2m per year for 10 years. With a strong focus on community engagement to develop a shared vision, intervention projects and plans to help build stronger communities, create thriving places and empower local people.

"Pride in place" in Herefordshire refers to projects and initiatives aimed at boosting community pride, belonging, and well-being through various means, including a focus on social history and cultural programming. These efforts are supported by government grants like the UK Shared Prosperity Fund (UKSPF) and are intended to create thriving neighbourhoods, support local arts and culture, and improve facilities.

We expect further information about the programme and timescales over the next few weeks and will be working with local members, communities and Jesse Norman MP South Herefordshire.

New garden waste service



Residents can now sign-up to a greener, cleaner, more convenient way to manage garden waste.

We're launching a new, subscription based, garden waste collection service in March next year (2026), and residents can sign up now to make sure they're ready.

This new service will replace the current garden waste collection, which uses single-use plastic sacks. Instead, residents will receive either a wheelie bin or reusable garden sacks, depending on available space at the property. The waste will be collected every two weeks, excluding two weeks at Christmas, and then turned into soil improver which will be available to buy at local recycling centres. The service is flexible, and residents can share bins with neighbours, add extra bins for larger gardens, or use reusable sacks if space is limited. The new service costs £60 per year, which equates to £2.40 per collection, plus a one-off delivery fee of £10 per bin.

Residents who sign-up before 9am on December 1, will automatically be entered into a prize draw to win one of ten free garden waste service annual subscriptions.

Operation Spotlight - continues



Everyone knows the rules around seatbelts, drink/drug driving, mobile phones and speeding so why are these issues still the most common reasons for collisions to occur? ONS figures show 4% drop in total crime in West Mercia

Crime continues to fall in West Mercia according to the latest figures from the Office for National Statistics. Delivering on PCC John Campion's commitment to 'Cutting crime', as set out in his Safer Communities Plan, total recorded crime fell by 4% between July 2024 and June 2025. This follows a 6% drop recorded earlier in the year.

Some of the biggest fallers include burglary at 19%, incidents of serious violence at 9%, overall theft at 8%, and shoplifting at 5%.

In contrast, sexual offences have increased by 9%, in line with the national average, and theft from a person has risen by 69 to 382 (22%).

Commenting on the figures, the PCC said: "A reduction in crime is always welcome, with this long-term trend a testament to the dedication of the hardworking men and women who make up West Mercia's thin blue line.

"In my role, I regularly engage with the public to understand their lived experiences as it cannot only be about the data, but also how safe they feel. "Those conversations make it clear that there's still more to do to ensure they feel the benefits of less crime, and at the same time, ensuring the resources are available to address some concerning upward trends.

"That's why I will continue to use my voice to support and challenge the Chief Constable to ensure crime rates are not just statistics, but a reflection of safer, more confident communities."

Autumn Road Safety Reminder



With the recent rain and the arrival of autumn, more mud and debris may be being brought onto rural roads by tractors and other farm or contractors' vehicles.

Under the Highways Act (1980), farmers and contractors must ensure their vehicles are cleared of mud and debris before entering the public highway. Excess mud can be extremely dangerous—it affects how vehicles handle, increases the risk of

skidding, and poses particular hazards for motorcyclists and cyclists.

Any incidents of mud on the road causing an issue can to be reported to the relevant local highways authority or if this poses an immediate danger call 101.

If you suddenly find there is mud on the road that you are on reduce your speed and keep a larger distance between you and the vehicle in front in case, you need to react.

Let's all do our part to keep safe on the roads this season.

Gullies are individually marked on the map with latitudes and longitudes being displayed along with a site code, which is used to identify the length of road where the asset is located.

Reporting gullies that need attention:

Issues reported are investigated by the relevant Locality Steward, who assesses the report against the Highway Maintenance Plan in order to determine the level of intervention required. Where necessary a job for a reactive cleanse is then raised and passed to a crew to attend.

Council tax reduction or exemption

You can get money off your Council Tax bill, or even pay nothing, in certain circumstances. A discount or exemption depends on your current situation and circumstances but does not take account of income or savings. If you are on a low income, you may also be able to get help to pay your bill through Council Tax Reduction. We will need to assess your financial and other circumstances to see what help you qualify for.
